REGULAR BUSINESS:

1. Mrs. Dana Buddecke made a motion to approve the last month’s minutes and checks written. Mr. Jeff Keller seconded the motion and the motion passed, all in favor.
2. Mr. Jeff Keller made a motion to approve the 2020 Rollback Tax rate of .334937. Mr. Jack York seconded the motion and the motion passed with none opposed.
3. Mr. Jeff Keller made a motion to approve the 2021 Budget for Texas Eastern 9-1-1 Network. Mrs. Dana Buddecke seconded the motion and the motion passed, all in favor.
4. Mr. Jack York made a motion to approve 2020/2021 school year TISD Resource Officer Contract. Mr. Tate Smith seconded the motion and the motion passed, all in favor.
5. Discussion on Road Repair Budget for 2020/2021. Due to invoices not being paid on the 2019/2020 road repair budget, we are now over on the current budget.
