IF DURING THE COURSE OF THE MEETING COVERED BY THIS NOTICE, THE BOARD SHOULD DETERMINE THAT A CLOSED OR EXECUTIVE SESSION OF THE BOARD, OR A CONSULTATION WITH THE CITY'S ATTORNEY AS AUTHORIZED BY CHAPTER 551 OF THE GOVERNMENT CODE OF TEXAS , AS AMENDED, WILL BE HELD BY THE BOARD AT THE DATE, TIME AND PLACE GIVEN IN THIS NOTICE AS THE BOARD CONVENIENTLY MEETS IN SUCH CLOSED OR EXECUTIVE SESSION (OR CONSULTS WITH THE CITY'S ATTORNEY) CONCERNING ANY AND ALL PURPOSES PERMITTED BY CHAPTER 551 OF THE GOVERNMENT CODE OF TEXAS, INCLUDING BUT NOT LIMITED TO ARTICLE 551.071' SECTION 1 OR 2; ARTICLE 555.072; ARTICLE 551.073; ARTICLE 551.074, SECTION 1 OR 2, (a) (b) (c) , ARTICLE 551.075, SECTION 1 OR 2; ARTICLE 551.076; ARTICLE 551.077 AND/OR ARTICLE 551.084.

SHOULD ANY ACTION, FINAL DECISION OR FINAL VOTE BE REQUIRED IN THE OPINION OF THE BOARD WITH REGARD TO ANY MATTER CONSIDERED IN THE CLOSED OR EXECUTIVE SESSION OR MEETING WITH THE CITY'S ATTORNEY, THEN SUCH FINAL ACTION, FINAL DECISION OR FINAL VOTE WILL BE AT EITHER:

*(1) the open meeting covered by this notice upon reconvening of this public meeting, or (2) at a subsequent public meeting of the Board upon notice thereof.*
