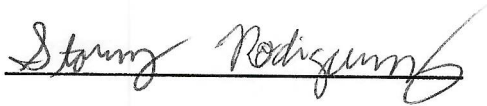
**Citizens:** Angela Davis did not show for meeting.

**Regular Meeting:**

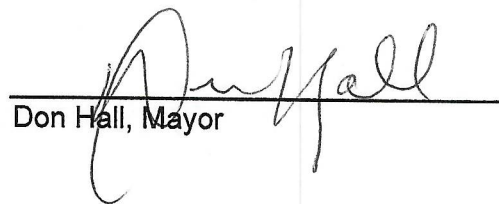
1. Last month's minutes and checks written- Jack made the motion to accept last month's minutes and checks. Kim second the motion and stated that Water Works need to initial their invoices because they know what the invoices are. All in favor and none opposed.
2. Wes Breitenberg from Waste connections shared his memories about Tatum Football. He gave a history of Waste Connection: they have owned their land field since 1998, he manages commercial accounts in Rusk, & Panola counties, has worked 20 plus years around our community, he provides the largest trash service- 3<sup>rd</sup> in the nation, with competitive prices, community involvement, town clean ups and he lives in Henderson. He would like to come back with pricing for the community at the next meeting.
3. Crawford Yoes- water bill increased with his electric. Mr. Yoes is asking for reimbursement for \$129.00. Mayor Don said that they would look into it and get back with him.
4. Bob Harris did not show up.
5. Executive Session 5:49pm- To discuss personnel for City Secretary & Chief of Police. Executive session returned to regular session at 8:13pm

9. Motion made by Kim to have ETCOG manage our SLFRF (State and Local Fiscal Recovery Funds) grant for 5%. Tate made the second motion. Motion carried with none opposed.
