SHOULD ANY ACTION, FINAL DECISION OR FINAL VOTE BE REQUIRED IN THE OPINION OF THE BOARD WITH REGARD TO ANY MATTER CONSIDERED IN THE CLOSED OR EXECUTIVE SESSION OR MEETING WITH THE CITY'S ATTORNEY, THEN SUCH FINAL ACTION, FINAL DECISION OR FINAL VOTE WILL BE AT EITHER:

*(1) the open meeting covered by this notice upon reconvening of this public meeting, or (2) at a subsequent public meeting of the Board upon notice thereof.*
