Mayor Henry promptly called the meeting to order at 5:30 pm.

Councilman Tate Smith was not present.

Mr. John Walton of 1370 Falcon in Eagle Ridge requested that the city issue a desist to stop trailer homes from moving into Eagle Ridge. Mr. Walton wanted to know if this was allowed or not. Councilman Moore stated that there is no ordinance in place to prevent it. The only zoning ordinance in place is at the 4-way. Per Mr. Walton, a few years ago, a letter was sent to the citizens stating this was a deed-restricted property. Councilmen Palmer asked if something was on file at the courthouse. He noted that if a letter had been sent, Joe Shumate, the previous City Attorney, would have filed it. Carol McIlhenny of 1320 Blue Bird said that those existing mobile homes in the area were grandfathered. Citizen Malantha Palmer noted that according to the September 2021 minutes, the City Council agreed to grandfather those existing mobile homes. Citizen R. Flores of 1390 Falcon said this is the 3rd time this issue has come up, and they were assured this would not be allowed. He said it was unacceptable because it was bringing down property values. The council agreed to look into it.

Discussion and Motion to approve the Selection Committee for the 2025-26 RFP Selection. Gregg Cole motioned to approve the Selection Committee members as Mayor Michael Henry, City Secretary Jacqueline Muckleroy, and Councilmen Robin Palmer.
